In exercise of the powers conferred by clause (2) of Article 229 of the Constitution of India, Hon'ble the Chief Justice, has been pleased to make following amendment in the Allahabad High Court Private Secretaries (Conditions of Service) Rules, 2001:-

## THE ALLAHABAD HIGH COURT PRIVATE SECRETARIES (CONDITIONS OF SERVICE) (AMENDMENT) RULES, 2019.

- 1. Short title and commencement: (i) These rules may be called "The Allahabad High Court Private Secretaries (Conditions of Service) (Amendment) Rules, 2019."
- (ii) These rules shall come into force from the date of publication in Official Gazette.
- 2. Insertion of sub-Rule (v) in Rule 5:- The following provisions shall be inserted after sub-Rule (iv) of Rule 5 under heading "Appointment, Promotion and Confirmation" of the Allahabad High Court Private Secretaries (Conditions of Service) Rules, 2001:-
- (v) Registrar-cum-Principal Private Secretary- By promotion from Joint Registrar-cum-Private Secretary Grade-IV.
- 3. Amendment in sub-Rule (ii) and insertion of sub-Rule (iii) in Rule 6:- The provisions of sub-Rule (ii) shall be amended and sub-Rule (iii) shall be inserted in Rule 6 under heading "Appointment, Promotion and Confirmation" of the Allahabad High Court Private Secretaries (Conditions of Service) Rules, 2001, as follows:-
