## ORDER NO. 42

Recently a very unfortunate incident took place in Agra judgeship, in which a Ld. Counsel was murdered within the judgeship itself which reflected a major lapse in the security. This incident has been taken very seriously by the Hon'ble Court and it has been directed to ensure that fool-proof arrangements be made in the security of High Court, Lucknow. A high-level meeting with the Chief Secretary, Govt. of U.P. was also held recently to review the security arrangements in the High Court as well as the various district courts.

In order to ensure proper security of the Hon'ble Court, all the officers and staff members of High Court, Lucknow had been directed to submit their details in the prescribed format for the preparation of high-tech RFID-tag based identification system for vehicles as well as identity cards. However, it has come to the knowledge of the undersigned that despite several reminders, till date many officers as well as staff members are yet to submit their details in the prescribed format.

All the officers of the Registry as well as all the sectional heads are hereby directed to ensure that all the staff members working under them should submit their details in the prescribed format (format is available on the official website) in all circumstances by 18.07.2019 in the office of Registrar(Security), failing which their entry in the campus of Hon'ble Court may be restricted.
