## ORDER

The written test result of Deputy Registrars Promotional Examination conducted on 3<sup>rd</sup> August, 2019 is produced before me. The examination was conducted in accordance with provisions of Rule 20 of the Allahabad High Court Officers and Staff (Conditions of Service and Conduct) Rules, 1976. On going through the entire Scheme of the Rules, especially the provisions relating to assessment of a candidate for appointment by way of promotion, it reveals that no definite pass marks are prescribed to qualify the Promotional Examination. The Promotional Committee settled 40% of maximum marks necessary to qualify the examination. The participation of the candidates was subsequent to four and a half months training relating application of law in the working of the High Court. Out of 71 candidates, who appeared in the examination, six candidates, namely, S/Sri Akhilesh Chandra, Anil Kumar Srivastava – III, Arvind Kumar Srivastava, Haider Husain Shabi, Jalilur Rehman and Shiv Prasad Srivastava failed to secure 40% of the maximum marks.

On going through the service record of all the above named six persons, it reveals that they are quite experienced persons and otherwise their service conduct is satisfactory. It would also be appropriate to state that the requirement of undergoing law training was introduced in the Rules vide notification no. 131 dated 4.1.2019 and the instant one is the first examination for the purposes of promotion to the post of Joint Registrar from the post of Deputy Registrar.

Having considered all these facts, while invoking powers under Rule 41 of the Rules of 1976, I deem it appropriate to relax the requirement of qualifying marks relating to all the six candidates named above. All the six candidates be also treated as the persons qualified in the examination. The result be declared accordingly.
