Subject: E-Services for Judicial Officers of Uttar Pradesh.

Sir,

This is to inform that a Web-based eServices Portal <u>https://dc.allahabadhighcourt.in</u> for the Judicial Officers of Uttar Pradesh was inaugurated by Hon'ble Mr. Justice Govind Mathur, Chief Justice, in the august presence of Hon'ble Judges of High Court Allahabad on 30 August 2019. Allahabad High Court is the first High Court of the Country to start/launch eServices which will ensure paperless working of High Court on Administrative side.

The main feature of the above Software is that it contains the facility of handling different types of Leave Applications, Annual Confidential remarks of Judicial Officers and filing of Periodic Property Statement online, a number of Other e-Services such as Miscellaneous requests or other communication with High Court are also provided under this module. The Officers can track their request status/progress online. All such application/request will be processed online & the approval of Competent Authority shall also be through the above software.

The above e-Services for serving Judicial Officers posted in District Courts and on deputation is being started from 01.09.2019. The above eServices is available on dc.allahabadhighcourt.in. The list of such services covered for the Judicial Officers is attached as annexure 'A'.

In this regard, I am directed to communicate that from 01.09.2019 onwards, all such requests/applications/representations covered under the above e-Services shall be processed through the above e-Services Portal only. Any document, which is required to be attached alongwith the application is to be attached after self attestation by individual Judicial Officer

Such Judicial Officers, who have already moved any application or request in physical form covered under the above e-Services, need not be sent again through the above portal.

No application covered under the above e-Services shall be entertained in hard copy or by e-mail from 01.09.2019 onwards. The individual login id. and password is being sent through mail.

OSD (J) CPC shall be the Nodal Officer, who will provide the Technical Assistance. Necessary assistance of the System Officers and System Assistants may be taken at local level.
