1	Bail – 54650/2019	<p>“This bail application was nominated to Hon’ble Justice Om Prakash-VII in light of the order dated 13th December, 2019 passed by the Court.</p> <p>The matter came up before the Court nominated on 20th December, 2019. The Court directed the office to place the record before the Chief Justice with observation that at no point of time, the bail application was dealt with by the Court nominated.</p> <p>As per the Allahabad High Court Rules, a second bail application is required to be placed before the same Judge who considered and decided the first application. However, any application preferred by co-accused as per provisions of Section 439 of the Code of Criminal Procedure, 1973 that is not required to be placed before the Bench that considered and decided the application of other accused persons in the same case crime.</p> <p>In light of the applicable provisions, such application is required to be examined by the appropriate Bench at its own merits.</p> <p>In view of it, let this application be listed before the Bench having roster to hear such matters.”</p>	Bail Section on 04.01.2020
