- 5. All cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
- 6. W.e.f. 13th of July, 2020, urgency applications for hearing of LISTED matters may be filed in physical form and such applications will be placed before Hon'ble Court having jurisdiction over the matter in effective Constitution of Benches as on date, provided Urgency/Listing/other likewise applications in the TU/PH matters shall be placed before the TU/PH Bench.
- 7. Only those LISTED matters shall be listed in Courts, for which urgency applications are allowed by the Court; except Listed Single Bench and Division Bench Criminal Appeals upto the year 1990 and all application under Section 11 of the Arbitration and Conciliation Act, 1996, which shall be listed as per this Constitution of Benches without requirement of any urgency applications. Such matters shall be listed only in Additional Cause List.
