- 5. All cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
- 6. The High Court shall function in accordance with the Modalities and Arrangement during COVID-19 (as issued time to time).
