Hon'ble the Acting Chief Justice, High Court of Judicature at Allahabad has been pleased to pass the following order on 30th of April 2021:

“Vide letter No. 898/ACS/2021 dated 30.04.2021 Sri Awnish Kumar Awasthi, Additional Chief Secretary, Government of Uttar Pradesh, while referring to Government Order No. 775/2021-CX-3 dated 29.04.2021, has informed that it has been decided to implement Corona Curfew from 08:00 p.m. of 30.04.2021 till 07:00 a.m. of 04.05.2021. It has been further requested to consider non functioning of the High Court at Allahabad and Lucknow during this period in order to stop the surge in the spread of COVID-19.

In light of the above Corona Curfew and with an intent to thwart the surge in the spread of COVID-19, it is directed that there shall be no sitting of Courts in the High Court at Allahabad and Lucknow on 03rd of May 2021.

Further, there shall be no e-filing from 01st to 03rd of May 2021 in the High Court at Allahabad and Lucknow.”

In view of the above, I am directed to communicate that all Judicial as well as Administrative Sections of the High Court at Allahabad and Lucknow, shall not function, on 01st and 03rd of May 2021.
