- 2. During Summer Vacation, in absence of the Senior Vacation Judge, the next Senior most Vacation Judge shall exercise jurisdiction as postulated in Chapter V Rule 10 (2) of the Rules of the Court, 1952, at Allahabad.
- 3. In Civil cases and Writ Petitions which require immediate attention, as postulated in 2nd part of sub-rule 1 of Rule 10 of Chapter V of the Rules of the Court, 1952, a separate paragraph showing the urgency be specifically mentioned in the petition itself.
- 4. There is no need to file Urgency Application with regard to the matters pertaining to Criminal Misc. Bail Applications, Anticipatory Bail, Criminal Appeal U/s 14 A (2) S.C. /S.T. Act, Criminal Revisions filed under Section 102 of the Juvenile Justice Act, 2015, Habeas Corpus Writ Petition and Writ Matters pertaining to Arrest/Stay of Arrest either in fresh cases or filed cases. The aforesaid cases shall be placed before the Hon'ble Court as usual. However, in all other matters (fresh as well as filed), Urgency Application will be filed and these matters shall be placed before the Hon'ble Court only after the Urgency Application is allowed by the Special Benches constituted.
- 5. The matters in which Urgency Application is allowed and fixed for any date during summer vacation shall be listed on the date fixed before appropriate Special Benches. Similarly, the matters fixed for any date during summer vacation, in category of cases in which Urgency Application is not required, as mentioned in para 4, shall be listed on the date fixed before appropriate Special Benches.
- 6. Urgency applications shall be placed before the Bench having jurisdiction over the matter, provided urgency applications in TU/PH matters shall be placed before the TU/PH Bench.
- 7. The Daily Cause List shall not be printed/published till further orders.
- 8. All cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
- 9. The High Court shall function in accordance with the Modalities and Arrangement during COVID-19 (as issued time to time).
