Note:

1. The cases shall be placed before the Hon'ble Court in accordance with order of Hon'ble The Acting Chief Justice/Chief Justice and Hon'ble Senior Judge passed from time to time in this regard.
2. P.I.L. (Civil and Criminal), Application under Article 228 of the Constitution of India, Tolls on river bridges in U.P. Matters and Environment matters shall not be listed in Court on 28th and 29th of June, 2021.
3. In view of pandemic of COVID-19, the roster dated 03.06.2021 w.e.f. 7th of June, 2021 shall remain inoperative till further orders.
4. Orders dated 04.12.2018 and 16.01.2019 regarding listing of only Listed matters on Wednesdays and date fixed fresh cases on next working day and exempting Bail applications from above orders, shall remain in abeyance till further order(s).
5. There shall be no requirement of Urgency Applications in **Fresh** matters.
6. There is no need to file Urgency Application with regard to the **LISTED** matters pertaining to Supreme Court Expedited matters, Criminal Misc. Bail Applications, Anticipatory Bail Applications, Criminal Appeal U/s 14 A (2) S.C. /S.T. Act, Criminal Revisions filed under Section 102 of the Juvenile Justice Act, 2015, Habeas Corpus Writ Petition, Civil matters pertaining to demolition, recovery and eviction and Writ Matters pertaining to Arrest/Stay of Arrest. The aforesaid cases shall be placed before the Hon'ble Court as usual. However, all other **LISTED** matters shall be placed before the Hon'ble Court only after the Urgency Application is filed and allowed by the Special Benches constituted.
7. Urgency Applications shall be placed before Hon'ble Courts as per order dated 26.06.2021
8. Due to COVID-19 pandemic, the Daily Cause List shall not be printed/published till further orders. The Listed matters shall be listed in the Additional Cause List.
9. Priority hearing of Criminal Revisions filed under Section 102 of the Juvenile Justice Act, 2015.
10. All cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
11. The High Court shall function in accordance with the Modalities and Arrangement during COVID-19 (as issued time to time).
