- · Attested copy of proof of practice at High Court, Allahabad.

The applications shall be accepted at the counters earmarked for the purpose in the **Fresh Filing Centre from 27.01.2015 to 28.02.2015**.

It is clarified that Advocates who had passed their qualifying (LL.B. or LL.M.) Examination in the year 2009-10 and thereafter, will be provisionally enrolled unless they furnish the proof of their passing the All India Bar Exam (AIBE) conducted by the Bar Council of India.
