Pre-Requisites for Applying Online	
	Before applying online, candidates should
(i)	Have a receipt/journal no. after depositing requisite fee (Rs.850/- for General/OBC category and Rs.600/- for SC/ST category) in the State Bank of India at any Branch in India on prescribed challan which may be downloaded from the website (The candidate have to submit High Court's copy with the downloaded / printed system generated filled application form.)
Filling	in the Online Application
(i)	Please note that all the particulars mentioned in the online application including Name of the Candidate, Date of Birth, Address, Category, etc. will be considered as final and no modifications will be allowed after submitting the Online Application. Candidates are hence requested to fill in the online application form with the utmost care as no correspondence regarding change of details will be entertained and permissible.
(ii)	Candidates should carefully fill in the details in the On-Line Application at the appropriate places very carefully and click on the "SUBMIT" button at the end of the On-Line Application format. Before pressing the "SUBMIT" button, candidates are advised to verify every particular filled in the application. The name of the candidate or his /her father/husband etc. should be spelt correctly in the application as it appears in the certificates/mark sheets. Any change/alteration found at later stage may disqualify the candidature.

(v)	No acknowledgment will be given for online registration. However, a Login Id and Password will be generated. If a candidate does not get online generated Login Id and Password, he/she should go to 'Application Printout / Reprint link to login and then click on 'Forgot Password' and provide the details as required he/she specified in the application form.
