Pursuant to Government Order of Appointment No. 4674/ VII-Nyay-1-11-196/ 2010 dated 20.12.2011, newly recruited Court Managers were appointed/posted as Court Managers vide Court's notification in the Hon'ble High Court, its Lucknow Bench and the courts subordinate to the High Court against the post created vide Government Order No. 4799/VII-Nyay-1-10-196/ 2010 dated 15.2.2011.
