4. The Division Bench comprising Hon'ble Dr. Justice **K.J. Thaker** and Hon'ble Mr. Justice **Dinesh Pathak** will sit in Court no.37 to take up the determination to be taken up there.
5. Hon'ble Mr. Justice **Salil Kumar Rai** (Court no.9) in addition to the cases of Court no.9, will take up the fresh cases, Additional Cause List cases and Applications of Court no.21 (Hon'ble Mr. Justice Dinesh Pathak).
6. Hon'ble Mr. Justice **Piyush Agrawal** will sit singly in Court no.10 and will take up the fresh cases, Additional Cause List cases and Applications of Court no.10 (Hon'ble Mr. Justice Siddhartha Varma).
