**Notes:**

1. All the previous Supplementary Constitutions of Benches ordered before this Constitution of Benches shall not be operative.
2. Mentioning, if any of Single Bench cases shall be made before the Senior most Single Bench available among all the Benches having the jurisdiction over the matter as per the Constitution of Benches except Part Heard and Tied Up matters.
3. Mentioning, if any of Division Bench cases shall be made before the Senior most Division Bench available for Civil matters for Division Bench Civil cases and Senior most Division Bench available for Criminal matters for Division Bench Criminal cases as per the Constitution of Benches except Part Heard and Tied Up matters.
4. Mentioning of any cases pertaining to jurisdiction specially assigned to any Court shall be made before such court except Part Heard and Tied Up matters.
5. Priority hearing of those criminal appeals where the accused has undergone more than half the sentence in view of Section 436A Cr.P.C. and the accused is in jail.

6. Priority hearing of matters relating to murder, rape, dacoity and kidnapping.
7. Priority hearing of those cases wherein mediation is successful.
8. Priority hearing of Criminal Revisions filed under Section 102 of the Juvenile Justice Act, 2015.
9. There shall be **no requirement of Urgency Applications** in **Fresh** and **Listed** matters.
10. Due to the COVID-19 pandemic, the Daily Cause List shall not be printed/published till further orders. The Listed matters shall be listed in the Additional Cause List.
11. The High Court shall function in accordance with the Modalities and Arrangement during COVID-19 (as issued time to time).
