- 8. There shall be no requirement of Urgency Applications in Fresh and Listed matters.
- 9. Due to the COVID-19 pandemic, the Daily Cause List shall not be printed/published till further orders. The Listed matters shall be listed in the Additional Cause List.
- **10.** The High Court shall function in accordance with the Modalities and Arrangement during COVID-19 (as issued time to time).
