7. Hon'ble Mr. Justice Rajiv Gupta (Court No.68) in addition to his own determination, will take up the Additional Cause List/Unlisted cases from serial nos.3001 to 3034 of Court No.65 (Hon'ble Mr. Justice Vivek Chaudhary), on 20.07.2022.
8. Hon'ble Mr. Justice Vivek Kumar Singh (Court No.69) in addition to his own determination, will take up the Additional Cause List/Unlisted cases from serial nos.3035 to 3068 of Court No.65 (Hon'ble Mr. Justice Vivek Chaudhary), on 20.07.2022.
9. Hon'ble Mr. Justice Ajay Bhanot (Court No.70) in addition to his own determination, will take up the Additional Cause List/Unlisted cases from serial nos.3069 to 3104, Applications and remaining determination of Court No.65 (Hon'ble Mr. Justice Vivek Chaudhary), on 20.07.2022.
10. Hon'ble Mr. Justice Dinesh Pathak (Court No.32) in addition to his own determination, will take up the determination of Court No.30 (Hon'ble Mr. Justice Chandra Kumar Rai), on 20.07.2022.
11. Hon'ble Mr. Justice Ashutosh Srivastava will sit singly in Court No.93 after Division Bench work and will take up cases of Single Bench F.A.F.O. starting from the oldest, on 20.07.2022, 21.07.2022 and 22.07.2022.
