In exercise of powers conferred by clause (2) of Article 229 of the Constitution of India, Hon'ble the Chief Justice has been pleased to make the following amendment in The Allahabad High Court Officers and Staff (conditions of service and Conduct) Rules, 1976.

**THE ALLAHABAD HIGH COURT OFFICERS AND STAFF
(CONDITIONS OF SERVICE AND CONDUCT) (AMENDMENT)
RULES, 2023**

1. Short title and Commencement.- (1) These rules may be called "The Allahabad High Court Officers and Staff (Conditions of Service and Conduct) (Amendment) Rules, 2023".

(2) These Rules shall come into force with immediate effect.

2. Definition.- In these rules, unless the context otherwise requires, 'Rules' mean "The Allahabad High Court Officers and Staff (Conditions of Service and Conduct) Rules, 1976".
