

## **ARRANGEMENT**

1. The Division Bench comprising Hon'ble Mr. Justice Anjani Kumar Mishra and Hon'ble Mr. Justice Arun Kumar Singh Deshwal will sit in Court No.43 to take up the determination to be taken up there.
2. Hon'ble Mr. Justice J. J. Munir (Court No.33) in addition to his own determination, will take up the fresh cases from serial nos.1 to 24, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.2 (Hon'ble Mr. Justice Saral Srivastava).
3. In modification of earlier order dated 26.07.2023, Hon'ble Mr. Justice Neeraj Tiwari (Court No.87) in addition to his own determination, will take up the fresh cases from serial nos.96 to 120 of Court No.87 (Hon'ble Mr. Justice Neeraj Tiwari), which were earlier transferred to Court No.2 (Hon'ble Mr. Justice Saral Srivastava).
4. In modification of earlier order dated 26.07.2023, Hon'ble Mr. Justice Piyush Agrawal (Court No.5) will take up the fresh cases from serial nos.1 to 3, Applications and remaining determination of Court No.5, which were earlier transferred to Court No.6 (Hon'ble Mrs. Justice Manju Rani Chauhan) and will also take up the Additional/Unlisted cases of Court No.5, which were earlier rotated as per cycle of Court No.5.
5. In modification of earlier order dated 26.07.2023, Hon'ble Mrs. Justice Manju Rani Chauhan (Court No.6) in addition to her own determination, will take up the fresh cases from serial nos.1 to 23, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.52 (Hon'ble Mr. Justice Saurabh Srivastava).
6. In modification of earlier order dated 26.07.2023, Hon'ble Mr. Justice Chandra Kumar Rai (Court No.51) in addition to his own determination, will take up the fresh cases from serial nos.146 to 245 of Court No.51 (Hon'ble Mr. Justice Chandra Kumar Rai), which were earlier transferred to Court No.52 (Hon'ble Mr. Justice Saurabh Srivastava).
7. Hon'ble Mr. Justice Anish Kumar Gupta (Court No.92) in addition to his own determination, will take up the fresh cases from serial nos.1 to 38, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.93 (Hon'ble Mr. Justice Arun Kumar Singh Deshwal).

1. The Additional/Unlisted cases of Court No.2 (Hon'ble Mr. Justice Saral Srivastava) shall be rotated as per the rotation cycle of Court No.2.
  2. The Additional/Unlisted cases of Court No.52 (Hon'ble Mr. Justice Saurabh Srivastava) shall be rotated as per the rotation cycle of Court No.52.
  3. The Additional/Unlisted cases of Court No.93 (Hon'ble Mr. Justice Arun Kumar Singh Deshwal) shall be rotated as per the rotation cycle of Court No.93.
  4. The matters transferred or assigned in this order are except TU/PH.
