

ARRANGEMENT

Hon'ble Mr. Justice Neeraj Tiwari (Court No.87) in addition to his own determination, will take up the fresh cases from serial nos.1 to 19, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.92 (Hon'ble Mr. Justice Anish Kumar Gupta) and will also take up the fresh cases from serial nos.1 to 7, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.93 (Hon'ble Mr. Justice Arun Kumar Singh Deshwal), on 21.09.2023.
6. Hon'ble Mr. Justice Ashutosh Srivastava will sit singly in Court No.38 and in addition to the cases shown in Court No.38 (Hon'ble Mr. Justice Ashutosh Srivastava), will take up the fresh cases from serial nos.88 to 157 of Court No.51 (Hon'ble Mr. Justice Chandra Kumar Rai), on 21.09.2023.
7. Hon'ble Mr. Justice Kshitij Shailendra (Court No.10) in addition to his own determination, will take up the fresh cases from serial nos.1 to 34 of Court No.9 (Hon'ble Mr. Justice Rohit Ranjan Agarwal), on 21.09.2023.
8. Hon'ble Mr. Justice Manjive Shukla (Court No.36) in addition to his own determination, will take up the fresh cases from serial nos.35 to 68, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.9 (Hon'ble Mr. Justice Rohit Ranjan Agarwal), on 21.09.2023.
