

## **ARRANGEMENT**

7. Hon'ble Mr. Justice Saurabh Srivastava (Court No.52) in addition to his own determination, is assigned the fresh cases from serial nos.64 to 83 of Court No.51 (Hon'ble Mr. Justice Chandra Kumar Rai), on 17.10.2023.
