

ARRANGEMENT

In modification of earlier order dated 28.10.2023, Hon'ble Mr. Justice Mayank Kumar Jain (Court No.85) in addition to his own determination, will take up the fresh cases from serial nos.295 to 374 of Court No.50 (Hon'ble Mr. Justice Ram Manohar Narayan Mishra) and will also take up the fresh cases from serial nos.101 to 194 of Court No.50 (Hon'ble Mr. Justice Ram Manohar Narayan Mishra).
9. Hon'ble Mr. Justice Shiv Shanker Prasad (Court No.82) in addition to his own determination, will take up the fresh cases from serial nos.195 to 294, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.50 (Hon'ble Mr. Justice Ram Manohar Narayan Mishra).

In modification of earlier order dated 28.10.2023, Hon'ble Mr. Justice Manish Kumar Nigam (Court No.47) in addition to his own determination, will take up the fresh cases from serial nos.129 to 158 of Court No.51 (Hon'ble Mr. Justice Chandra Kumar Rai) and will also take up the fresh cases from serial nos.1 to 38, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.49 (Hon'ble Mr. Justice Syed Qamar Hasan Rizvi).
11. Hon'ble Mr. Justice Kshitij Shailendra (Court No.10) in addition to his own determination, will take up the fresh cases from serial nos.1 to 16, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.48 (Hon'ble Mr. Justice S. S. Shamshery).
