7. Hon'ble Mr. Justice Vipin Chandra Dixit (Court No.79) in addition to his own determination, will take up the fresh cases from serial nos.1 to 80 of Court No.82 (Hon'ble Mr. Justice Shiv Shanker Prasad), on 01.11.2023.
8. Hon'ble Mr. Justice Subhash Chandra Sharma (Court No.80) in addition to his own determination, will take up the fresh cases from serial nos.81 to 141, Applications and remaining determination (except the Additional/Unlisted cases) of Court No.82 (Hon'ble Mr. Justice Shiv Shanker Prasad), on 01.11.2023.
9. Hon'ble Mr. Justice Surendra Singh-I will sit singly in Court No.82 at 2.00 P.M. till the formation of Regular Division Bench in Court No.32 and will take up the fresh cases from serial nos.238 to 277 of Court No.50 (Hon'ble Mr. Justice Ram Manohar Narayan Mishra), on 01.11.2023.
