

ARRANGEMENT

1. In modification of earlier order dated 07.03.2024, Hon'ble Mr. Justice Siddharth will sit singly in Court No.90 and will take up the determination of Court No.90 (Hon'ble Mr. Justice Vikram D Chauhan) and will also take up the determination of Court No.92 (Hon'ble Mr. Justice Prashant Kumar).
2. Hon'ble Mr. Justice Ajay Bhanot (Court No.64) in addition to his own determination, will take up the determination of Court No.72 (Hon'ble Mr. Justice S. A. H. Rizvi).
3. In modification of earlier order dated 07.03.2024, Hon'ble Mr. Justice Piyush Agrawal (Court No.70) in addition to his own determination, will take up the complete determination of Court No.71 (Hon'ble Mrs. Justice Manju Rani Chauhan), which were earlier divided between Court Nos.70 and 72.

In modification of earlier order dated 07.03.2024, Hon'ble Mr. Justice Krishan Pahal (Court No.75) in addition to his own determination, will take up the fresh cases from serial nos.130 to 209 of Court No.76 (Hon'ble Mr. Justice Sameer Jain) and will also take up the remaining determination of Court No.76 (Hon'ble Mr. Justice Sameer Jain).
7. Hon'ble Mrs. Justice Renu Agarwal (Court No.81) in addition to her own determination, will take up the fresh cases from serial nos.1 to 64 and the Additional/Unlisted cases from serial nos.3001 to 3063 of Court No.84 (Hon'ble Mr. Justice Nalin Kumar Srivastava).
8. Hon'ble Ms. Justice Nand Prabha Shukla (Court No.85) in addition to her own determination, will take up the determination (except the fresh cases from serial nos.1 to 64 and the Additional/Unlisted cases from serial nos.3001 to 3063) of Court No.84 (Hon'ble Mr. Justice Nalin Kumar Srivastava).
