The staff of Fresh Filing Counter shall feed all the matter in the Courts as per jurisdiction allotted

- The entire work will be done automatically.
- Fresh Filing Counter shall have no access or control on distribution of Fresh cases.
- Staff of Fresh Filing Counter will know the allocation of cases only after allocation is done by the system.
- To make the system automatic, the allocation shall be done by a separate user not sitting or connected with the Fresh Filing Counter.
- No individual case feeding in any Court is permitted under the new system, all left over cases shall also be allocated through the Case Allocation System.
- SMS's/emails shall be send to the registered mobile nos./email ids of counsels immediately after the publication of list.
- The bench wise list of common jurisdiction shall be available on all Courts having common jurisdiction so that counsels can check/find the cases in one place of common nature.

1. Considering the inflow of various type of fresh cases, the benches have accordingly been constituted to manage fresh cases equally and effectively like:

- (a) The fresh matters pertaining to **Writ-C** Division Bench have been allocated among 4 Division Benches;
- (b) The fresh matters pertaining to **<u>Criminal Writ</u>** Division Bench have been allocated among 4 Division Benches;
- (c) The fresh matters pertaining to <u>**Civil Contempt**</u> Single Judge Bench have been allocated among 3 Single Judge Bench;
- (d) The fresh matters pertaining to <u>Writ-C</u> Single Judge Bench have been allocated among 6 Single Judge Benches;
- (e) The fresh matters pertaining to **Writ-A** (service) Single Judge Bench have been allocated among 5 Single Judge Benches;
- (f) The fresh matters pertaining to <u>Writ-B</u> Single Judge Bench have been allocated among 2 Single Judge Benches;
- (g) The fresh matters pertaining to **Second Appeal** Single Judge Bench have been allocated among 2 Single Judge Benches;
- (h) The fresh matters pertaining to <u>applications under Section 482 &</u> <u>483 Cr.P.C.</u> Single Judge Bench have been allocated among 7 Single Judge Benches; and
- (i) The fresh matters pertaining to **bail application (major/ minor)**Single Judge Bench have been allocated among 6 Single Judge Benches.

2. The above fresh matters will be spun by a computer generated programme and equally distributed among respective Benches of same roster of fresh cases.

3. The programme by which fresh cases will be spun, is not within the control of any manual intervention, even the button for spin runs only once a day.

4. The above system of fresh distribution has been prepared looking into the convenient and comfort of learned counsel and litigant public as the list of fresh cases will be prepared a day before and every learned lawyer and litigant would know in advance where the fresh cases are being listed on the next day.

5. The above system further provides the relief to the learned lawyers and litigant from morning transfer/arrangement of fresh cases.

6. The above roster provides equal distribution of fresh cases among the Hon'ble Benches and would provide sufficient time for the Hon'ble Courts to know the list of fresh cases being listed in their Court.

7. Considering the pendency of cases pertaining to Division Bench civil nature, Division Bench criminal nature, Single Judges civil nature and Single Judges criminal nature, 7, 9, 21 and 21 benches, respectively, have been constituted for effective disposal of cases.
