NOTICE

The High Court Legal Services Sub-committee Lucknow Bench, Lucknow is preparing a panel of Advocates in consonance to Chapter-III, Regulation 17(1) of High Court Legal Services Committee, Regulation, 1997 and Rule 8 of National Legal Services Authority (Free and Competent Legal Services Authority) Regulations, 2010.

Applications are, therefore, invited in the given format from legal practitioners having experience of three years and more at the Bar for their empanelment as panel advocate. The Advocates who are desirous to conduct the cases or proceedings on behalf of the persons entitled for legal aid, legal advice or legal services may apply. The panel lawyers shall conduct the cases before Hon'ble High Court and Central Administrative Tribunal, Board of Revenue at Lucknow and other Authorities constituted under any law, other than District Courts. Persons facing proceedings or adjudged guilty under the Criminal Law, Contempt of Courts Act or under the Advocates Act need not apply.

Application form along with detailed instructions, terms and conditions of empanelment can be downloaded from Official website of Allahabad High Court (www.allahabadhighcourt.in). The lawyers are requested to refer to the instructions before filling the application form.

That candidate must apply on the format prescribed by the High Court Legal Services Sub-Committee, Lucknow Bench, Lucknow only. The candidate shall enclose self attested photocopy of Degree of Law and Certificate of enrolment issued by State Bar Council under the Advocates Act, 1961 and an experience certificate issued by the Oudh Bar Association along with the application form. Applications shall be accompanied with proof of the professional experience with special reference to the type of cases. The candidate shall affix the latest passport size colored photograph on the application form and sign the same in such a manner that part of signature appears on the form and part on the photograph.

Complete Application Form along with requisite documents shall be submitted in the office of Joint Registrar (J) Listing/Secretary, High Court Legal Services Sub-Committee, Room No.9, High Court Lucknow Bench, Lucknow from <u>28.01.2019</u> to <u>06.02.2019</u> between 11.00 AM to 01:00 PM & 02:00 PM to 04:00 PM on any working day.

The result will be made available on Official website of Allahabad High Court (www.allahabadhighcourt.in) and on the notice board of the High Court Lucknow Bench, Lucknow. The new panel shall be for a period of three years commencing from the date of appointment. Panel Advocates will be paid fees as per approved Schedule of Fees.

If work of the panel Advocate is found unsatisfactory or the Advocate is found to be guilty of charging or collecting or demanding any remuneration from an aided person in any form or he/she contravenes the Scheme of the Act, Rules and the Regulations he / she be removed from the panel. The work assigned by the Sub-Committee has to be attended on priority basis. No case assigned by the Committee should go unattended for the reason that the Ld. Advocate is busy in his private matter. This is important as instances like this create apprehension in the minds of the Legal Aid beneficiaries that the case was not attended as they are not paying the professional fee.
