Hon'ble the Chief Justice, High Court of Judicature at Allahabad has been pleased to pass the following order :

"By the order dated 18^{th} March, 2020, 19^{th} , 20^{th} and 21^{st} March, 2020 were declared as Holidays in the High Court of Judicature at Allahabad as well as at Lucknow. The period aforesaid was extended upto 25^{th} March, 2020 on 21^{st} March, 2020.

Keeping in view the gravity of the situation arising due to outbreak of novel coronavirus (COVID-19), it would be appropriate to extend the Holidays upto 28th March, 2020.

The judicial functioning of this Court with its ancillary staff during this period shall be restricted only to the cases of utmost urgency, only on mentioning between 10:00 am to 11:00 am. before Registrar (Judicial) (Listing) at Allahabad on Mobile No. 9532693559 and in his absence before Joint Registrar (Judicial) (Criminal) at Allahabad on Mobile No. 9473838827; and Registrar (Judicial) (Listing) at Lucknow on Mobile No. 9415028118 and in his absence before Registrar (Judicial) (Stationery) on Mobile No. 9412711100, who shall obtain orders in this regard from the nominated Hon'ble Judge(s). The mentioning will be made only on mobile phone of the abovesaid Officer(s) that will be restricted only to fresh filing.

During this period, the Registry shall not entertain any ordinary filing. If the limitation of any case expires on or after 19th March, 2020 and during this period, the benefit of this period shall be extended on the same pattern as during the regular vacations.

The matters fixed for 26^{th} & 27^{th} March, 2020 shall be listed on 9^{th} and 10^{th} April, 2020 respectively.

In view of the fact that 26^{th} , 27^{th} & 28^{th} March, 2020 have already been declared as holiday, no daily cause list is required to be printed and published for the period upto 1^{st} April, 2020."
