ORDER

It is brought to my notice that several Lawyers are mentioning urgency for listing the minor bail applications relating to minor offences which were in the fresh list of 19 March, 2020 and daily cause-list of 18th & 19th March, 2020.

It is also detailed to me by the Registrar (J)(Listing) that good number of minor bail applications are pending consideration.

In view of the facts stated above, I deem it appropriate to get the minor bail applications and Criminal Writ Petitions under Article 226 of Constitution of India where prayer is made for stay of arrest which were in the fresh list of 19 March, 2020 and daily cause-list of 18-03-2020 and 19-03-2020 be listed before the Hon'ble Court on 09 and 10 April, 2020 as follows:

Singh, J. (Court No. 13) and cases of Minor Bails shown in the Daily Cause-lists dated 18-03-2020 and 19-03-2020 shown before Hon'ble D.K. Singh, J. (Court No. 13).
