7. The administrative order dated 15-11-2018 and 20-06-2019 regarding nominated matters will continue in operation.
8. All cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
