- 1. Multi-level parking will be used by litigants, pairokars and government officers only for the parking of their vehicles.
- No vehicle will be allowed to park outside the premises of this Hon'ble Court i.e. in the service lane from Gate No.3, 4, 5, 6 & 8.
- 3. Only ground, first and second floors of Multi-level Parking will be opened w.e.f. 02.02.2021 on trial basis and no parking fee will be charged till further orders.
- 4. Four wheelers will be parked on the ground floor, while two wheelers will be parked on first and second floor.
- 5. Entry will be ensured only from Gate No.8 and exit from Gate No.10 only.
- 6. Vehicle lift will be opened while passengers' lift will be closed.
- 7. Prescribed slip will be provided by the concerned Learned Counsels to the litigants and pairokars and office of Chief Standing Counsel will provide slips to Government Officers for parking of their vehicles in the Multi-level Parking.
- 8. No vehicle will be allowed to enter or remain in the Multilevel Parking after 07.00 P.M.
- 9. Deputy Commissioner of Police (Security) and Assistant Commandant, CRPF are directed to ensure smooth ingress and egress of the vehicles in the area and remain vigilant.
- 10. Civil Police and CRPF will ensure that vehicles will not be allowed to park in haphazard manner in the Multi-level Parking area and no slider in between Gate No.8 to Gate No.10 will be opened without permission of authority.

- 11. Concerned authority of UPRNN is directed for the full cooperation of smooth functioning of the Multi-level Parking of this Hon'ble Court.
- 12. All the vehicles will be parked in the Multi-level Parking at the risk of owners.
