Notice

In continuation to the earlier Notices dated 31.07.2020, 24.08.2020, 22.09.2020, 20.10.2020, 18.01.2021 and 24.02.2021 regarding submission of Tender Form and deposition of Subscription Fee for the Paper Cause List for the period 19.02.2021 to 18.02.2022, it is hereby informed that under the Orders of the Hon'ble Court, another opportunity is being provided from 19.03.2021 to 19.04.2021 for submitting the Tender Form and deposition of Subscription Fee for the Paper Cause List for the aforesaid period i.e. 19.02.2021 to 18.02.2022 @ Rs.600/- (Six Hundred) only, subject to upward revision (if any) and the arrears so accrued will be realized from the subscribers accordingly.

It is also hereby informed that as the Paper Cause List was not printed and distributed in the second half of the preceding period (i.e. 21.09.2019 to 20.09.2020) due to prevailing COVID-19 Pandemic, so the Hon'ble Court has been pleased to order for adjustment of the balance amount of Rs.300/- remaining from the preceding subscription period, in the following manner :

- (i) The amount of Rs.300/- (which is the balance amount out of Rs.600/-, fixed for the preceding subscription period) shall be adjusted for the current subscription period 19.02.2021 to 18.02.2022 of those subscribers who had deposited subscription fee of Rs.600/- for the preceding period (i.e. 21.09.2019 to 20.09.2020) and wish to deposit subscription fee for the current period (i.e. 19.02.2021 to 18.02.2022).
- (ii) The amount of Rs.300/- (which is the balance amount out of Rs.600/-, fixed for the preceding subscription period) shall be adjusted for the next subscription period after 18.02.2022, of those subscribers who had already deposited subscription fee of Rs.600/- for the preceding period (i. e. 21.09.2019 to 20.09.2020) and also for the current period (i. e. 19.02.2021 to 18.02.2022).

Note : *The amount realized / adjusted from the subscribers is subject to upward revision (if any) and the arrears so accrued will be realized from the subscribers accordingly.*

The Subscription Fee as mentioned above is to be deposited in the Cash Section after getting the Tender document verified from the Counter earmarked in the Registry Section **from 10:00 A.M. to 02:00 P.M. on all working days w.e.f. 19.03.2021 to 19.04.2021.**

The said staff shall also ensure for the passing of the Tender Forms by adjusting the amount of Rs.300/- of the eligible subscribers as per the conditions mentioned in the notice above.*
