2. During Summer Vacation, in absence of the Senior Vacation Judge, the next Senior most Vacation Judge shall exercise jurisdiction as postulated in Chapter V Rule 10(2) of the Rules of the Court, 1952, at High Court of Judicature at Allahabad, Lucknow Bench, Lucknow.

3. In Civil cases and Writ Petitions which require immediate attention, as postulated in 2nd part of sub-rule 1 of Rule 10 of Chapter V of the Rules of the Court, 1952, a separate paragraph showing the urgency be specifically mentioned in the petition itself.

4. There is no need to file Urgency Application with regard to the fresh matters pertaining to Criminal Misc. Bail Applications, Anticipatory Bail, Criminal Appeal U/s 14 A (2) SC/ST Act, Criminal Revisions filed U/s 102 of the Juvenile Justice Act, 2015, Habeas Corpus Writ Petition and writ matters pertaining to Arrest/Stay of Arrest. The aforesaid fresh cases shall be placed before the Hon'ble Court as usual. However, in all other fresh matters, Urgency Application will be filed and these matters shall be placed before the Hon'ble Court only after the Urgency Application is allowed by the Benches constituted.

5. All matters earlier fixed for period 17.05.2021 to 04.06.2021, both dates inclusive, will come up after the Summer Vacation, sequentially, except Supreme Court expedited matters.

6. The pending matters and the regular matters wherein the specific dates are fixed unless extremely exceptional and on application for hearing during summer vacation is allowed, are not to be listed during summer vacation.

7. Urgency applications shall be placed before the Bench having Jurisdiction over the matter.

8. The Daily Cause-List shall not be printed/published till further orders.

9. In view of pandemic of Covid-19, the roster w.e.f. 18-01-2021 (as modified time to time) shall remain inoperative till further orders.

10. All Cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.

11. The High Court of Judicature at Allahabad, Lucknow Bench, Lucknow shall function in accordance with the modalities and arrangement dated 17-04-2021 and onwards during Covid-19.
