- 1. - 6. Urgency Applications shall be placed before Hon'ble Courts as per order dated 26.06.2021
- 7. Due to COVID-19 pandemic, the Daily Cause List shall not be printed/published till further orders. The Listed matters shall be listed in the Additional Cause List.
- 8. Priority hearing of Criminal Revisions filed under Section 102 of the Juvenile Justice Act, 2015.
- 9. All cases where the vires of Central or State Legislation is challenged be listed before the appropriate Division Bench having jurisdiction over the matter falling under the legislation in issue.
- 10. The High Court shall function in accordance with the Modalities and Arrangement during COVID-19 (as issued time to time).
